## DOWNEAST DIRECT CREMATION, LLC GENERAL PRICE LIST

Effective Date: January 2, 2017, but subject to change without notice.

The goods and services shown within are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide, describing the funeral goods and services you selected.

**DIRECT CREMATION with alternate container** ..... **\$975**  
(\*within our service area) **COMPLETE®**

Our charge for direct cremation without any attendant rites or ceremonies (this means the public does not have the right to "attend" ceremonies or services, because you are choosing to NOT have any) includes removal from place of death, **48 hour shelter of remains**, transportation to local crematory, crematory fee, alternate container, burial/transit permit, Medical Examiner permit, necessary services of staff, return of cremated remains to designated person and postage fee.

This service does not include embalming or any other use of facilities. If you want to arrange for a direct cremation, you may use an alternate container. Alternate containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The alternate container we provide is a cardboard box.

**DIRECT CREMATION with container provided by purchaser** ..... **\$975.00**  
(\*within our service area)

Removal ..... **\$250.00**  
*If after calling us, you choose NOT to use our services, all transfers to other firms will be charged a MINIMUM fee of \$250 for the removal.*

Alternate Container ..... **\$125.00**  
*Rigid combustible container typically used for the cremation.*

\*Additional Mileage (per mile one way outside Denboscot, Hancock Piscataquis, or Washington County) ..... **\$7.00**  
*We reserve the right to charge additional mileage outside of our territory.*  
Additional Sheltering (per day) ..... **\$150.00**  
*In case of unusual delay, we reserve the right to charge additional climate-controlled sheltering of remains. Climate-controlled sheltering may also be charged on any transfers to other firms.*


